We did not report descriptive statistics because each open-source model was evaluated deterministically on the benchmark tasks. Our results reflect single-run evaluations rather than repeated experiments, in line with prior benchmarking work.

We did not explicitly report package parameters because we used widely adopted evaluation tools with their default settings. This follows standard practice in benchmarking.
