### A. Questions mandatory for all submissions.

*In Appendix G.1, we cite the creators of artifacts.*

- B2. Did you discuss the license or terms for use and/or distribution of any artifacts?

*In Appendix G.1, we discuss the license or terms for use.*

- B3. Did you discuss if your use of existing artifact(s) was consistent with their intended use, provided that it was specified? For the artifacts you create, do you specify intended use and whether that is compatible with the original access conditions (in particular, derivatives of data accessed for research purposes should not be used outside of research contexts)?

*In Appendix G.1, we discuss our use of existing artifacts are consistent with their intended use.*

- B4. Did you discuss the steps taken to check whether the data that was collected/used contains any information that names or uniquely identifies individual people or offensive content, and the steps taken to protect/anonymize it?

*In Appendix B and G.1, we only study math questions from public available math datasets, which don't contain any names that identify individual people or offensive content.*

*In Appendix G.1, we report that all of our data collected is English questions.*

- B6. Did you report relevant statistics like the number of examples, details of train/test/dev splits, etc. for the data that you used/created?

*In Appendix B, we report the number of collected examples in our final dataset and the source dataset. In Section 3.3 and Appendix E, we report the number of training examples for fine-tuning GPT-4o-mini.*

*The Responsible NLP Checklist used at ACL Rolling Review is adopted from NAACL 2022, with the addition of ACL 2023 question on AI writing assistance and further refinements based on ARR practice.*

**C. Did you run computational experiments?**

- C1. Did you report the number of parameters in the models used, the total computational budget (e.g., GPU hours), and computing infrastructure used?

*In Section 4 and Appendix E, we report the model size and computing infrastructure.*

- C2. Did you discuss the experimental setup, including hyperparameter search and best-found hyperparameter values?

*Experiment design is in Section 3.3. Evaluation framework is in Section 3.4 and Appendix D. Hyperparameters for models are in Appendix E.*

- C3. Did you report descriptive statistics about your results (e.g., error bars around results, summary statistics from sets of experiments), and is it transparent whether you are reporting the max, mean, etc. or just a single run?

*In Section 5 and 6, we report bootstrapping with 95% of confidence interval. They are in Table 1-5, Figure 5-6.*

- C4. If you used existing packages (e.g., for preprocessing, for normalization, or for evaluation, such as NLTK, SpaCy, ROUGE, etc.), did you report the implementation, model, and parameter settings used?

*The main packages are in Appendix G.1. We do not use existing packages that require setting hyperparameters.*

**D. Did you use human annotators (e.g., crowdworkers) or research with human subjects?**

*In Appendix G.2, we provide screenshots of the full text instructions.*

- D2. Did you report information about how you recruited (e.g., crowdsourcing platform, students) and paid participants, and discuss if such payment is adequate given the participants' demographic (e.g., country of residence)?

*In Appendix G.2, we report that we recruited three master's and PhD students for annotating the response of LLMs to compare it with verifier outputs and validate the effective of verifiers.*

- D3. Did you discuss whether and how consent was obtained from people whose data you're using/curating (e.g., did your instructions explain how the data would be used)?

*In Appendix G.2, we tell the students these results will be used to compare with predictions from LLM verifiers, but students are not provided with the verifier predictions to avoid cheating.*

- D4. Was the data collection protocol approved (or determined exempt) by an ethics review board?

*In Appendix G.2, we only collect annotation boolean values ("Yes" or "No") from annotators, which doesn't have any ethical issues. Thus, we don't require the approval from ethics review board.*

- D5. Did you report the basic demographic and geographic characteristics of the annotator population that is the source of the data?

*In Appendix G.2, we report that three annotators are from the Europe and the US.*

**E. Did you use AI assistants (e.g., ChatGPT, Copilot) in your research, coding, or writing?**

- E1. If you used AI assistants, did you include information about their use?

*In Appendix G.3, we report that we use AI assistants for basic AI code completions and grammar checking. We manually designed the structure of the code and implemented the basic logic of functions.*
