We describe the human-audit procedure and note that annotators followed bucket-specific rubrics (Section 3.5), but the full text of annotator instructions is not included in the paper.

The Responsible NLP Checklist used at ACL Rolling Review is adopted from NAACL 2022, with the addition of ACL 2023 question on AI writing assistance and further refinements based on ARR practice. ACL 2026 used a subset of ARR checklist form.

- D2. Did you report information about how you recruited (e.g., crowdsourcing platform, students) and paid participants, and discuss if such payment is adequate given the participants' demographic (e.g., country of residence)?

The human audit was conducted as an internal expert validation procedure rather than a paid participant study.

- D3. Did you discuss whether and how consent was obtained from people whose data you're using/curating (e.g., did your instructions explain how the data would be used)?

The work does not involve collecting personal data from participants for dataset curation; the benchmark is constructed from tool-augmented trajectories and recorded tool outputs, with screening/redaction for potential PII or secrets.

- D4. Was the data collection protocol approved (or determined exempt) by an ethics review board?

This work does not report a human-subject data collection study requiring ethics-board approval; the human audit serves as internal benchmark validation.

E. Did you use AI assistants (e.g., ChatGPT, Copilot) in your research, coding, or writing?

AI assistants were used only for language polishing and minor coding assistance; all technical content, experiments, and final verification were performed by the authors.
