The evaluation solely involved rating the quality of synthetic, fictional narrative texts. Under our institution's guidelines, such standard linguistic annotation tasks using healthy adult volunteers without collecting sensitive personal data are exempt from formal Ethics Review Board (IRB) approval.

We used large language models (e.g., ChatGPT/Gemini) exclusively for English proofreading, grammar correction. No AI was used to generate scientific claims or ideas.
