We used ChatGPT and Grammarly for polishing the language of the paper. ChatGPT also assisted with LaTeX issues. JetBrains Junie was used for coding assistance for auxiliary scripts, i.e., non-core/non-logic code, e.g., plotting and statistics summarization, exporting scripts, and the web UI implementation.
