*Our work focuses on improving model reliability and reducing false-certain errors, which inherently reduces risks associated with overconfident incorrect predictions. The primary contribution is making LLMs safer and more trustworthy for deployment. We did not identify significant additional risks beyond those already present in base LLMs, as our method strictly improves calibration without introducing new capabilities.*
