We use standard machine translation (MT) datasets that have been previously vetted, and to the best of our knowledge, there are no known issues related to privacy or inappropriate content.

Yes. Data statistics are reported in Section 4.1 and Appendix A.2. We report the WMT'14 En-De training size, the three En-De constrained test-set sizes, the WMT'17 Zh-En training size, and the final Zh-En constrained test-set size.
