*Section 5.1 provides a comprehensive description of the experimental setup, including data scales and configurations. However, the paper does not discuss the hyperparameter search process or the final hyperparameter values used for the LightGBM regression model.*

C3. Did you report descriptive statistics about your results (e.g., error bars around results, summary statistics from sets of experiments), and is it transparent whether you are reporting the max, mean, etc. or just a single run?

*The paper clearly identifies the main package used for the regression task as LightGBM (Section 5.1). However, it does not report the specific parameter settings (i.e., hyperparameters) that were used for this package.*
