We utilize standard, publicly available benchmark datasets (Natural Questions, HotpotQA, WebQuestions, and TriviaQA), relying on the data processing and anonymization standards established by their original creators. Consequently, no additional steps were taken to screen for offensive content or personally identifiable information.

This work relies entirely on existing public datasets and does not involve any human subjects or annotators.

We did not recruit or pay any participants, as this study does not involve human subjects or crowdsourcing.
