No participants were recruited or paid. All annotations were performed by four paper authors as part of their research activities; no external annotators, crowdworkers, or students were involved. As stated in Appendix A.16: "no external annotators, crowdworkers, or paid participants were used. As paper authors conducting their own research, no compensation was provided for annotation work"
