We provide a detailed description of the experimental setup in the paper. Due to the substantial computational cost of a single run, we did not conduct an extensive hyperparameter search. Instead, given that the proposed method already achieves strong and consistent performance under a fixed configuration, we focus on ablation studies to analyze the contribution of key components rather than tuning hyperparameters exhaustively.
