The participants are included as co-authors and volunteer to do human evaluations.

ePCR Data were provided by a local EMS agency under a formal data-sharing/data use agreement. The agency de-identified all ePCRs prior to release. Access was limited to authorized researchers and the data were used only for the purposes described in the agreement.

- D4. Was the data collection protocol approved (or determined exempt) by an ethics review board?

All dialogue dataset is generated by LLMs. The source de-identified ePCR data were provided under a data use agreement with a local EMS agency.
