Ethics Statement. We discuss potential privacy and security risks of multi-agent LLM systems and frame the work as defensive evaluation using synthetic data.

Section 4.1 and Ethics Statement. All experiments use synthetic, fabricated PII only, and we enforce a sanitization protocol so that no PII appears in the public context.

Section 4.1 and Appendix C.1. We describe the SPIRIT dataset and report dataset statistics, including 104 PII items and 25 background-question pairs.

Experimental Setup in Section 4 and Appendix C.1. We describe the models, agent counts, topologies, rounds, placement enumeration, and evaluation protocol. No hyperparameter search was performed.
