*We primarily utilize the Ego4D and Epic-Kitchens public datasets, which are already anonymized and scrubbed of offensive content by their respective providers. These datasets represent the gold standard in the field for privacy protection. As our dataset is a derivative of these sources, we inherit these protections. We also performed a manual review of our specific data samples to verify that no identifiable information or offensive content is present.*
